# President's Piece

# CSA and BetterLife Merger; New Beginnings, All While Keeping Legacy and Tradition



Brothers and Sisters.

I hope this month of February finds everyone well, as we inch toward warmer weather and Springtime.

As many of you may have heard by now, in early January, the CSA Board of Directors voted to merge CSA Fraternal Life with BetterLife, a Fraternal Society headquartered in Madison, Wisconsin.

First and foremost, I want to assure every member that the CSA Board took this step with deep thought after many months of discussion, due diligence, and planning. To give everyone some background, discussions began in earnest last Summer / Fall, 2024. Even as CSA Fraternal Life's finances have been (and remain) sound with your assets secure, the landscape for smaller Fraternals as we move into the future has become more and more challenging. Those chal-

lenges include an interest rate environment with significant swings in rates over these last few years that make for difficult investing and cash flow for smaller entities.

Additionally, as you all would know from living your personal lives, expenses have gone up significantly as well. For us personally, it may be groceries or gas, while for entities such as CSA, it's pricing in backoffice items, such as administrative systems, or other hardware and software items that put the squeeze on. Even more pressing, to be honest, the regulatory pressure that small entities (including CSA) receive from Insurance Regulators is as big of a factor as anything when it came time to consider a merger. There's no coincidence that a number of Fraternal mergers have taken place in recent years, and surely this trend will continue in 2025 and beyond.

With all of this said, I'm very proud of our Board in making the bold, strategic decision to partner with BetterLife. BetterLife was formed a few years ago when two century-old Fraternals (National Mutual Benefit and Western Fraternal Life) merged. As you may know, CSA and Western Fraternal have history together, as Western Fraternal Life spun off from CSA Fraternal Life at the beginning of the last century. To this day, CSA and BetterLife (via Western Fraternal) have a number of common threads. including many members of both societies. In researching potential partners, and doing our due diligence, the CSA Board wanted to assure a number of things...

First and foremost, our members' assets continue to be safe and secure. With BetterLife's \$70 million surplus, and RBC well over 1000%, our policies and annuities will remain very secure. There will be even more insurance products available for us to look into as members.

Next, we want to assure that the rich legacy and tradition of CSA continues. With this merger, CSA members will become BetterLife members, and our policies and annuities will be administered by BetterLife, but our legacy and tradition will live on in that our lodges and Fraternal programs will remain. BetterLife and CSA will continue to sponsor signature CSA events, such as our Annual Get-Together, with our crown jewel, the National Miss CSA Contest. All other lodge or district events that CSA has sponsored will continue as well. BetterLife currently sponsors over 50 signature events of their own and we'll add into that mix.

We want to assure that CSA has a legitimate governance influence in the decision-making process of BetterLife. This will be accomplished with CSA having one of our current Board members added to the BetterLife full Board. The other eight current Board members will be able to join the BetterLife Advisory Board, which in many ways is like what the CSA "Fraternal Board" used to be. CSA members will continue to have the opportunity to be a part of future BetterLife Board's as well.

# CSA and BetterLife Merger; New Beginnings, All While Keeping Legacy and Tradition

And, finally, we want to assure that our dedicated employees can remain with the combined society. This will be occurring as current CSA staff will be assuming roles with BetterLife, initially working out of our current office in Lombard. When the lease in Lombard is complete, employees will have the option to work remotely. Many of our current staff have the talent and knowledge that fits perfectly into roles that were being planned in BetterLife expansion of certain departments, again a nice synergy.

### What Happens Next?

Per our Articles of Incorporation and Bylaws, the Delegates that remain from our most recent (2022) Convention are in good standing and will need to approve this merger. Those Delegates will be receiving information from us in the weeks ahead on the voting process. Our thoughts are to have the ballots out to Delegates in February with a March deadline to vote and return the ballots.

# What Happens if the Delegates Do Not Approve of the Merger?

This would not be ideal. A few things would occur. First, of course, the agreed-upon merger would cease.

But, more pressing would be that after notifying the Regulators of this vote, they (specifically the Illinois Department of Insurance) have communicated with us that they would likely take action to ensure that CSA is ultimately partnered with a larger entity. What is this "action"? The exact action would be determined by the DOI, but it likely would be that they would oversee another merger for CSA. With this, though, yes, all of our policies and annuities would continue to be safe and secure, but it would be very likely that the legacy and tradition of CSA would cease or be very minimal at best.

Needless to say, the merger agreement that the CSA Board of Directors negotiated and approved is very much in the best interests of CSA members' financial and fraternal needs. So I highly encourage the Delegates to vote "yes".

# What Happens After Delegate Approval?

Regulatory approval from the 28 states that the combined entity will be licensed in will have to occur. From what the attorneys tell us, some states will approve of this in days, while others take longer. All states will ultimately approve this but it is unknown exactly when that will all happen. Within this merger, the combined entity will cease selling policies in New York and California due to regulatory issues. Members from those states will continue to keep their policies,

which will remain unscathed.

### Then What?

When all regulatory bodies have approved this, the merger will be official and will "close." This could be anywhere from July to December. In this time, CSA will begin to plan out the transition (i.e. combining administrative systems, pairing down duplicate vendors, etc.).

This is a lot of information, and a lot to digest. Again, do know that every little bitty detail of all of this has been poured over by CSA management and the CSA Board. I'm 100 percent in support of this proposed merger, and although change is scary for all, I truly know that this is in the best interests of CSA members and CSA lodges in that your polices will continue to be safe and secure and the CSA legacy and traditions will remain beyond the 171 years that we've built up to now.

We'll continue to keep everyone updated on the latest. Feel free to contact me or our Secretary / Treasurer Nick Kosmas if you have any questions.



BetterLife, based out of Madison, WI, has a history, mission, and values that are closely aligned with ours. In January 2021, two member-owned fraternal benefit societies with similar histories (Western Fraternal Life and National Mutual Benefit) came together to form BetterLife. Western Fraternal Life and CSA Fraternal Life share a common legacy, with Western Fraternal spinning off from CSA over a century ago. BetterLife has a complementary membership footprint, a focus on community wellness, and a strong Czech – Slovak heritage.

### Benefits of the merger include:

- We share a common heritage across Eastern Europe including the Czech Republic and Slovakia.
- Together we can expand the communities we serve, particularly in rural America
- Often our organizations work side-by-side but have not yet shared resources.
- With a proven, successful sales model, we can create a rising tide of membership.
- Financially we are stronger one auditor, actuary, investment manager, fees, dues.

This merger will allow us to grow our events further and provide more opportunities to develop lasting bonds with like-minded members. "BetterLife members understand that physical health is just one part of a healthy life. We like to say, 'Better means belonging,' because our member groups are about building relationships and being active in their communities," said Chris Campbell, BetterLife CEO and Board Chair. "CSA is a perfect match as we share a common bond to foster well-being by celebrating traditions, supporting one another, and strengthening financial security in our communities."

# **Questions & Answers**

### Why are we merging?

 Due to economic and regulatory challenges, along with the relatively smaller size of CSA. an independent future would be even more challenging for us to offer the great benefits that we currently do. Continued independence would also put a strain on the Balance Sheet in the years ahead. You can rest assured that your assets, as always, are safe and secure. That said, a combined CSA and BetterLife will allow for us to strengthen even more what we can offer, all while keeping our CSA legacy and history. Merging will allow us to cut redundancies in multiple areas (such as Actuarial services, and Audit services, etc) A combined CSA and BetterLife will be able to improve investment returns from a larger portfolio and integrate talent by filling vacancies at BetterLife with current CSA staff.

# What will BetterLife's capital position be after the merger?

Part of the merger rationale was a better use of BetterLife's excess capital. Following the merger, we estimate \$70 million in surplus with a risk-based capital ratio of 1065%, well above our upper bound of 900%. We expect this will continue the merger strategy BetterLife began in 2021 with the combination of Western Fraternal and National Mutual Benefit.

# What will happen to my policy/annuity?

Your policy/annuity will not change.

# What are the next steps in the merger timeline?

We will be sending ballots to delegates, from our 2022 convention, in February to vote on the merger. If approved, the next step will be approval from state insurance department regulators.

### What will happen to CSA's Fraternal functions?

BetterLife will honor Fraternal Benefit Societies' commitment to local governance, spending the first year getting to know CSA's culture, rituals, and systems. BetterLife is planning on increasing funding at select, signature CSA events like the Annual Miss CSA Contest to amplify our community impact.

### Why are we not integrating the Marketing function?

The CSA name has a rich history and is critical to our members. We will continue to use it in the 59 CSA Lodges and their associated events. The name will also be important as we elevate BetterLife's presence in the Czech and Slovak community, like their work with the Smithsonian's National Czech and Slovak Museum and Library.

### Will we still receive The Journal?

Prior to closing, The Journal will continue to be distributed monthly to our members. When the merger is complete, CSA Members will receive the BetterLife Magazine (which will have a portion of it dedicated to The CSA Journal).

### Will my Lodge still have meetings?

Yes, all Lodge meetings and structure will remain the same.

### Will we still have CSA events?

 Yes, all annual CSA events will remain the same through 2025.

# Will CSA's contact information change?

 Currently, all contact information will remain the same.

BetterLife and CSA hope to have the merger finalized in summer 2025. Members can expect additional details on the plan in the coming weeks. Members can email BetterLife (info@betterlifeins.com) or CSA (CSAFraternal@csalife.com) with any questions.







# 2025 CSA Fraternal Life Lodge Recognition Program

Awards for this program are granted to lodges that are well rounded and meet criteria in four areas:

- Service/Volunteer Hours/Donations Serving our communities is what we do. This area
  measures lodges by how they activate members to improve the communities around them.
- Lodge Activities/Attendance Our organization consists of a nationwide network of lodges. We
  maintain our bond by engaging in activities that unite our members on a local and national level.
  Our activities keep our society strong while honoring our lodge system and Fraternal programs.
- Social Engagement/Traditions/Rituals Social activity is what keeps our members together. In addition, CSA's fraternal history consists of various traditions and rituals that make up the backbone of this Society.
- Lodge Reporting (Sound Operations) The strongest lodges are the ones that meet regularly, maintain best business practices, and operate consistently with the CSA Home Office and Fraternal Department.

### NOTE: Required points have to be earned in each of these four categories to win an award.

Lodges with a healthy balance of the above criteria will be rewarded Platinum, Gold, Silver, or Bronze.
Important: Please keep in mind that one point does not equal one option. You may select a single option that can be as little as one point or as much as four points. For example, trying to earn a Platinum Award does not mean you have to choose 60 options, rather you have to earn 60 total points.

- To earn the Platinum Award (\$500 Award) designation, a lodge is required to earn sixty (60) points or more from the four categories plus hold 6 lodge meetings and donate 25% of your annual allotment to charity.
- To earn the Gold Award (\$350 Award) designation a lodge is required to earn forty-six (46) points or more from the four categories plus hold 5 lodge meetings and donate 25% of your annual allotment to charity.
- To earn the Silver Award (\$250 Award) designation a lodge is required to earn thirty-eight (38) points or more from the four categories plus hold 4 lodge meetings and donate 25% of your annual allotment to charity.
- To earn the Bronze Award (\$150 Award) designation a lodge is required to earn twenty-eight (28) points or more from the four categories plus hold 3 lodge meetings and donate 25% of your annual allotment to charity.

Monday, re-heat leftovers with rye bread with kmin (caraway seed).


Friday, plum dumplings with melted low priced spread.


# Czech Christmas Tree at Chicago City Hall
